3. Confidentiality and Security of Personal Information.

Except as otherwise provided in this Privacy Policy we will keep your Personal Information private and will not share it with third parties, unless such disclosure is necessary to: (a) comply with a court order or other legal process; or (b) protect our rights or property, in which case we will make every effort to contact you prior to disclosing the information. Your Personal Information is stored on secure servers that are only accessible by our employees and our technology provider. We provide you with the capability to transmit your Personal Information via secured and encrypted channels if you use a similarly equipped web browser. We will first obtain your permission to release your Personal Information to third parties, except where noted above.

4. Personal information and Credit Card Information is not retained by us.

For those who are registered to use the site to pay for products or services, you should know that we do not retain your personal information or the credit card information that you provide on our secure site.

5. Other Limits to Your Privacy.
